

AN ORDINANCE AMENDING ORDINANCE NO. 511, AS AMENDED, BEING AN ORDINANCE REGULATING TRAFFIC AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, AND REPEAL OF ORDINANCES IN CONFLICT THEREWITH.

WHEREAS, the Board of Trustees of the Town of St. John, Lake County, Indiana, did on the 9th day of April, 1979, adopt Ordinance No. 511, same being an ordinance regulating traffic and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana, and

WHEREAS, the Board of Trustees of the Town of St. John, Lake County, Indiana, did on the 14th day of March, 1983, amend said Ordinance by Ordinance No. 599, and

WHEREAS, it has become necessary to amend such Ordinance as amended, and any subsequent ordinances in conflict therewith; and

WHEREAS, it is in the best interest of the Town of St. John to amend Ordinance No. 511, as amended; to provide for said changes and additions.

NOW THEREFORE, BE IT ORDAINED by the Board of Trustees of the Town of St. John, Lake County, Indiana, that the Town of St. John Ordinance No. 511, as amended, and specifically Article XI thereof, shall include the following additional sections, to-wit:

"Yield the Right of Way Signs. 5. When yield the right of way signs are erected upon streets intersecting a through street at the entrance thereto, every driver of a vehicle approaching such an intersection shall yield the right of way to the vehicle proceeding on the through street intersecting the street whereupon the yield the right of way sign is erected as designated in Schedule 11 hereof, which is attached hereto and made a part hereof by reference. After yielding the right of way aforesaid, the vehicle reaching the intersection shall have the right of way to proceed, only if merging into the through street can be safely accomplished.

Children Playing Posted Signs. 6. Children playing posted signs shall be located at the intersections and upon the streets as provided in Schedule 12 attached hereto and made a part of this ordinance.


Dead-End Streets Posted Signs. 7. Dead-End streets posted signs shall be located at the intersections and upon the streets as provided in Schedule 13 attached hereto and made a part of this ordinance.

in Schedule 14, attached hereto and made a part hereof, every vehicle shall stop at every such stop sign or at a clearly marked stop line before entering the intersection. The first vehicle reaching an intersection shall, after stopping, have the right of way to proceed."


BE IT FURTHER ORDAINED that the Schedule Index of Ordinance No. 511, as amended, be amended to include the forgoing Schedules 11, 12, 13, and 14 accordingly, which Schedule Index is attached hereto and made a part hereof by reference, and that all other provisions of Ordinance No. 511, as amended, not in conflict herewith shall remain in full force and effect.

BE IT FURTHER ORDAINED that an emergency exists for the immediate taking effect of this ordinance, and therefore, the same shall be in full force and effect from and after its passage upon proper posting by the clerk/treasurer.




