

ORDINANCE NO. 668

AN ORDINANCE AMENDING ORDINANCE NO. 511, AS AMENDED, BEING AN ORDINANCE REGULATING TRAFFIC AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS OF THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, AND REPEAL OF ORDINANCES IN CONFLICT THEREWITH.

WHEREAS, the Board of Trustees of the Town of St. John, Lake County, Indiana, did on the 9th day of April, 1979, adopt Ordinance No. 511, same being an ordinance regulating traffic and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the Board of Trustees of the Town of St. John, Lake County, Indiana, did on the 14th day of March, 1983, amend said ordinance by Ordinance No. 599; and

WHEREAS, the Board of Trustees of the Town of St. John did on the \_\_\_\_ day of January, 1985, amend said ordinance by Ordinance No. 650; and

WHEREAS, it has become necessary to again amend such ordinance as amended, and any subsequent ordinances in conflict therewith; and

WHEREAS, it is in the best interest of the Town of St. John to amend Ordinance No. 511, as amended, to provide for said changes and additions.

NOW THEREFORE, BE IT ORDAINED, by the Board of Trustees of the Town of St. John, Lake County, Indiana, that the Town of St. John Ordinance No. 511, as amended, and specifically ARTICLE VIII thereof, shall read as follows, to-wit:

ARTICLE VIII

RESTRICTED STREETS

Deliveries on Restricted Streets by Trucks. 1. From and after the taking effect of this ordinance, all streets and alleys of the Town of St. John, except those set out in Schedule 5, shall be designated as Restricted Streets, and it shall be unlawful for the driver of any truck, excepting trucks in the following four categories: (a) Those of less than ten (10) tons rated capacity, (b) House moving vans, (c) Construction vehicles to drive upon same except for the purpose of

making a delivery or carrying on business in the block in which such vehicle is being driven, and any driver making such delivery shall enter same at the first intersection nearest point of delivery and leave same at first intersection after such delivery, and (d) Other trucks, to drive upon same except for the purpose of making a delivery or carrying on business in the block in which such truck is being driven. Any driver of any such truck making such delivery, shall enter same at the first intersection nearest point of delivery and leave same at first intersection after such delivery.

BE IT FURTHER ORDAINED that Schedule 5 referred to above shall be amended to include only (a) U.S. Rt. 41, and West 93rd Avenue shall be eliminated from (a), and (b), (c), (d) and (e) shall be likewise eliminated.


BE IT FURTHER ORDAINED that the Town of St. John Ordinance No. 511, as amended, and specifically, ARTICLE XI thereof, shall include the following additional section, to-wit:


No Through Street Posted Signs. 9. No through street posted signs shall be located at the intersections and upon the streets as provided in Schedule 15 attached hereto and made a part of this ordinance.

BE IT FURTHER ORDAINED that the Schedule Index of Ordinance No. 511, as amended, be amended to include the foregoing Schedule 15 accordingly, which Schedule Index is attached hereto and made a part hereof by reference, and that all other provisions of Ordinance No. 511, as amended, not in conflict herewith shall remain in full force and effect.

BE IT FURTHER ORDAINED that an emergency exists for the immediate taking effect of this ordinance and, therefore, the same shall be in full force and effect from and after its passage upon proper posting by the clerk/treasurer.
