

ORDINANCE NO. 723

AN ORDINANCE AMENDING ORDINANCE NO. 511,
AS AMENDED, BEING AN ORDINANCE REGULATING
TRAFFIC AND ESTABLISHING FINES AND PENALTIES
FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE
TOWN OF ST. JOHN, LAKE COUNTY, INDIANA AND
REPEAL OF ORDINANCES IN CONFLICT THEREWITH

WHEREAS, the Board of Trustees of the Town of St. John, Lake County, Indiana, did adopt Ordinance No. 511, the same being an ordinance regulating traffic and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the Board of Trustees of the Town of St. John, Lake County, Indiana, did amend said ordinance by Ordinance No. 599; and

WHEREAS, the Board of Trustees of the Town of St. John, Lake County, Indiana, did further amend said ordinance by Ordinance No.'s 650, 668, and 698; and

WHEREAS, it has become necessary to amend such ordinance, as amended, and any subsequent ordinances in conflict therewith; and

WHEREAS, it is in the best interests in the Town of St. John to amend Ordinance No. 511, as amended, and more particularly ARTICLE XI, "THROUGH STREETS" thereof, to provide for said changes and additions.

NOW, THEREFORE, BE IT ORDAINED, by the Board of Trustees of the Town of St. John, Lake County, Indiana, that ARTICLE XI, "THROUGH STREETS" of Ordinance No. 511, as amended, and more particularly, SCHEDULE 7 thereof designated "STOP STREETS" shall include the following additions:

Hilltop and Larimer Drive
Acorn and Acorn Court
Acorn and 96th Avenue
Northcote and 97th Court
Northcote and 96th Court
Northcote and 94th Place
Lantern Drive and 88th Court

BE IT FURTHER ORDAINED, that the foregoing were formerly yield the right of way signs and formerly found on SCHEDULE 11 of Ordinance No. 511, designated "YIELD RIGHT OF WAY SIGNS", and they are hereby deleted from the aforesaid SCHEDULE 11.

BE IT FURTHER ORDAINED that an emergency exists for the immediate taking effect of this ordinance; that there being unanimous consent of the members of the Board of Trustees present; and that a two-thirds (2/3) vote is required for the passage of ordinances on the same as introduced, this ordinance shall take effect upon its passage and adoption by the Board of Trustees, the affixing of their signatures thereto, and upon the posting by the Clerk/Treasurer in each district within the Town of St. John in a public place pursuant to law.
