

AN ORDINANCE AMENDING ORDINANCE #771 AND ALL AMENDMENTS THERETO BEING AN "ORDINANCE ESTABLISHING A SCHEDULE OF WAGES AND SALARIES FOR THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, FOR TOWN EMPLOYEES, FIRE AND POLICE PERSONNEL AND TOWN OFFICIALS."

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, finds it appropriate to amend the schedule of wages and salaries for the Town of St. John, Lake County, Indiana, for Town Employees, Town Officials, Police Personnel, Fire Personnel, Water Department, Street Department, Building Department, and Sewer and Sanitary District.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, finds it proper and appropriate to set forth a schedule for payment of such salaries and wages and;

WHEREAS, pursuant to Acts of the State of Indiana (1905), Chapter 129, Section 30, Page 219, the compensation of the Council Members, Clerk-Treasurer, Chief of Police, other Town Officials and Town Employees for services shall be as the Town Council of the Town of St. John, Lake County, Indiana, finds it proper and appropriate to establish the following wages and salaries and schedule of payment thereof.

NOW, THEREFORE, BE IT ORDAINED, by the Town Council of the Town of St. John, Lake County, Indiana, that the following schedule of wages and salaries and dates of payment, therefore, for Town Employees, Fire and Police Department personnel, and Town Officials be and are hereby established and shall commence January 1, 1990 to wit:

R. Police Sergeant	\$30,737.00 per year, payable in the amount of \$1,182.19 every two weeks from the General Fund.
S. Police Corporal	\$29,424.00 per year, payable in the amount of \$1,131.69 every two weeks from the General Fund.
T. Patrolman 1st Class	\$28,396.00 per year, payable in the amount of \$1,092.15 every two weeks from the General Fund.
U. Patrolman 2nd Class	\$24,966.00 per year, payable in the amount of \$960.23 every two weeks from the General Fund.
V. Probationary Officer	\$23,663.00 per year, payable in the amount of \$910.11 every two weeks from the General Fund.
W. Police Officers (Highway Safety Grant)	Police Officer's prevailing hourly wage.
X. Building Commissioner	\$22,801.00 per year, payable in the amount of \$652.14 from the General Fund, \$112.41 from The Water Utility, and \$112.41 from the Sewer Utility, every two weeks.
Y. Fire Chief	\$8.00 for each call or run within the corporate limits of the Town of St. John, \$7.00 for each call or run within the area under contract with the St. John Township Trustee, payable bi-annually from the General Fund. (June 30 & December 15)
Z. Assistant Fire Chief	\$7.00 for each call or run within the corporate limits of the Town of St. John, \$6.00 for each call or run within the area under contract with the St. John Township Trustee, payable bi-annually from the General Fund. (June 30 & December 15)
AA. Firemen	\$6.00 for each call or run within the corporate limits of the Town of St. John, \$5.00 for each call or run within the area under contract with the St. John Township Trustee, payable bi-annually from the General Fund. (June 30 & December 15)
BB. Firemen Training	\$10.00 for each practice session attended, payable bi-annually from the General Fund. (June 30 & December 15)
CC. Police Officer Retired	\$14,269.00 per year, payable in the amount of \$1,171.50 per month for the first six months (January through June) and \$1,206.50 per month for the last six months (July through December) of 1990, from the Metro Police Pension Fund.

EE. Police Department Longevity: The amount earned will be based on two year increments with the first year of employment not receiving any credit towards this program, as technically it is still a probationary year.


