

ORDINANCE NO. 855

AN ORDINANCE AMENDING ORDINANCE NO. 823 AND ALL AMENDMENTS THERETO BEING AN "ORDINANCE ESTABLISHING A SCHEDULE OF WAGES AND SALARIES FOR THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, FOR TOWN EMPLOYEES, FIRE AND POLICE PERSONNEL AND TOWN OFFICIALS"

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, finds it appropriate to amend the schedule of wages and salaries for the Town of St. John, Lake County, Indiana, for Town Employees, Town Officials, Police Personnel, Fire Personnel, Water Department, Street Department, Building Department, and Sewer and Sanitary District.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, finds it proper and appropriate to set forth a schedule for payment of such salaries and wages and;

WHEREAS, pursuant to Acts of the State of Indiana (1905), Chapter 129, Section 30, Page 219, the compensation of the Council Members, Clerk-Treasurer, Chief of Police, other Town Officials and Town Employees for services shall be as the Town Council of the Town of St. John, Lake County, Indiana, finds it proper and appropriate to establish the following wages and salaries and schedule of payment thereof.

NOW, THEREFORE, BE IT ORDAINED, by the Town Council of the Town of St. John, Lake County, Indiana, that the following schedule of wages and salaries and dates of payment, therefore, for Town Employees, Fire and Police Department personnel, the Town Officials be and are hereby established and shall commence January 1, 1991 to wit:

- A. Director of Public Works \$36,972.78 per year, payable in the amount of \$474.01 every two weeks from MVH, Water Utility and Sanitary District Funds.
- B. Class I, Water, Street or Sewer Department Foreman \$30,924.14 per year, payable in the amount of \$1,189.39 every two weeks from the Water Utility, Sewer Utility MVH Funds.
- C. Class II, Water, Street or Sewer Department Employees \$29,958.76 per year, payable in the amount of \$1,152.26 every two weeks from Water Utility, Sewer Utility or MVH Funds.
- D. Class III, Water, Street or Sewer Department Employees \$27,730.56 per year, payable in the amount of \$1,066.56 every two weeks from the Water Utility, Sewer Utility or MVH Funds.
- E. Sanitary District Employee \$27,733.94 per year, payable in the amount of \$1,066.69 every two weeks from the Sanitary District Fund.
- F. Waterworks District Employee \$27,733.94 per year, payable in the amount of \$1,066.69 every two weeks from the Waterworks District Fund.
- G. Class IV, Water, Street or Sewer Department Employee \$24,964.42 per year, payable in the amount of \$960.17 every two weeks from the Water Utility, Sewer Utility or MVH Funds.
- H. Class A Miscellaneous Help-Part Time, Street, Water, Sewer or Park Department \$10.71 per hour, payable every two weeks from Water Utility, Sewer Utility or Park Funds.
- Class B Miscellaneous Help-Part Time, Street, Water, Sewer or Park Department \$8.68 per hour, payable every two weeks from Water Utility, Sewer Utility or Park Funds.
- Class C Miscellaneous Help- \$6.88 per hour, payable every two weeks from Water Utility, Sewer Utility or Park Funds.

Also, the longevity pay for the Public Works Department shall be paid out of the following funds; MVH, Sanitary District, Water Utility, and Sewer Utility.

LL. Police Department Uniforms - Initially, when a new member is employed by the Police Department (excluding Police Department radio operators), said new employee shall receive for his uniforms clothing, equipment, etc., the sum of \$550.00. After one (1) year of service, said new Police Department employee will then be entitled to the regular uniform allowance designated by the Town.

With regard to regular Police Department members (excluding radio operator employees), each member shall be entitled to a \$600.00 regular uniform allowance, to be paid in increments of \$150.00 quarterly. With regard to full time radio operator employees, they shall be entitled to a \$400.00 regular uniform allowance, to be paid in increments of \$100.00 quarterly. With regard to part time radio operator employees, they shall be entitled to a \$150.00 regular uniform allowance, to be paid in increments of \$37.50 quarterly.


That any and all ordinance or parts thereof establishing compensation, wages, or salaries for Town Employees, Police Personnel, Fire Personnel, and Town Officials, in conflict with the provisions of this ordinance, be and the same are hereby repealed.

That an emergency exists for the immediate taking effect from and after its passage and the compensation and salary referred to herein shall be paid as set forth herein beginning on January 1, 1991 and continuing thereafter.


