

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO. 942

AN ORDINANCE AMENDING TOWN ORDINANCE NUMBER 938, BEING: AN ORDINANCE ESTABLISHING THE SCHEDULE OF WAGES AND SALARIES FOR THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, FOR THE TOWN EMPLOYEES, FIRE AND POLICE PERSONNEL AND TOWN OFFICIALS, AND ALL AMENDMENTS THERETO, AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, did, on the 15th day of November, 1993, pass Ordinance No. 938, thereby establishing the jobs and salaries to be paid certain offices, positions, and jobs with the Town; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has reviewed the terms and provisions of Town Ordinance No. 938, and all amendments passed subsequent thereto; and

WHEREAS, the Town Council of the Town of ST. John, Lake County, Indiana, has particularly reviewed the terms and provisions of Town Ordinance No. 938, and all amendments passed subsequent thereto regarding the employee health benefits; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has determined after its review of the terms and provisions of Town Ordinance No. 938, and all amendments passed subsequent thereof, that the provisions of said ordinance pertaining to the employee health benefits require modification.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA:

SECTION ONE: That the specified employee health benefits within the following section of Town Salary Ordinance No. 938, and all amendments passed subsequent thereto, entitled "Employees Health Benefits", be, and the same are hereby amended as follows, namely:

"S. Employees Health Benefits

Each full time employee shall be provided health and life insurance at the cost of twelve (\$12.00) dollars per employee per year (\$1.00 per month), with the remaining costs to be paid by the Town. An employee may elect to include dependents within the health insurance provided by the Town at the cost of the Employee, which costs under the current policy shall be as follows:

Spouse only	\$240.14 per month
Spouse & Children	\$297.10 per month"

SECTION TWO: That all remaining terms and provisions of Town Salary Ordinance No. 938, and all amendments passed subsequent thereto, not inconsistent with the terms and provisions of the within Ordinance, are hereby reaffirmed and ratified.


SECTION THREE: That all existing Ordinances, Guidelines, Regulations or parts thereof, in conflict with the provisions of this Ordinance, are hereby deemed null, void, and of no legal effect, and are specifically repealed.

SECTION FOUR: If any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this Ordinance.

SECTION FIVE: That this Ordinance shall take effect, and be in full force and effect, from and after its passage by the Town council of the Town of St. John.
