

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO. 1089

AN ORDINANCE ESTABLISHING THE FEES FOR THE ST. JOHN HEALTH & FITNESS CENTER.

WHEREAS, the Town of St. John, Lake County, Indiana, by and through its Town Council, has entered into a Ground Lease/Operating Agreement for the lease of the St. John Ice Arena; and

WHEREAS, the foregoing Ground Lease/Operating Agreement provides that the Town of St. John and/or its assignee shall operate the Health & Fitness Center located therein; and

WHEREAS, it has therefore become necessary for the Town Council of the Town of St. John, Lake County, Indiana to establish fees and charges for the use of such facility by members of the public; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana does hereby find that the schedule of fees as set forth below is fair and reasonable under all the circumstances, and in the best interest of the residents of the Town of St. John, Lake County, Indiana.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that the following schedule of fees for the St. John Health & Fitness Center shall be as follows, to-wit:

I. Enrollment Fees. Enrollment fees are based upon continuous membership. If membership is cancelled and member later rejoins, member will be subject to an additional membership fee. Membership enrollment fees shall currently be established as follows:

- A. Single membership \$40.00
- B. Family membership \$60.00
- C. Additional family members \$20.00

II. Monthly Fees. There shall be monthly fees fixed and established as follows:

A. Single	\$32.00	\$35.00	\$50.00
B. Couple	\$50.00	\$60.00	\$80.00
C. Family members	\$18.00	\$20.00	\$25.00

D. Seniors	\$25.00	\$25.00	\$35.00
E. Restricted	\$20.00	\$25.00	\$35.00

Family members are children 17-23 years of age and residing in the same home and residence. Seniors rates are available for those 62 years and older. Restricted rates are for use of the facility at a specific time to be established by management.

BE IT FURTHER ORDAINED that the rates aforesaid may be changed from time to time.

BE IT FURTHER ORDAINED that if a member prepays for the first year prior to the opening of the facility, that member shall be entitled to a \$50.00 discount.

BE IT FURTHER ORDAINED that if any section, clause, provision, or portion of this ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this ordinance.


