ORDINANCE NO. ///

BEING AN ORDINANCE AMENDING ORDINANCE NO. 511, AND ALL AMENDMENTS THERETO, THE SAME BEING AN ORDINANCE REGULATING TRAFFIC, AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, on the 9th day of April, 1979, passed and adopted Ordinance No. 511, the same being an ordinance regulating traffic, and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the foregoing Ordinance has been amended on numerous occasions in order to protect the health, safety, and welfare of the citizens of the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from Kenneth Ubriaco and Laura Ubriaco to prohibit parking in a designated area in front of their residence at 8731 Verbena Court, St. John, Indiana for the reason that Laura Ubriaco suffers from a debilitating disease and is handicapped; that she is picked up for therapy on a regular basis by a van; that the van, due to regulations, will not pull into the driveway; and that it is imperative for Laura Ubriaco, due to her condition, to receive her therapy and to be picked up; therefore, it is imperative that no one park in a designated area in front of the residence at 8731 Verbena Court, St. John, Indiana; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has come to the conclusion that parking in a designated area in front of 8731 Verbena Court, St. John, Indiana should be prohibited; that a sign indicating handicapped pick-up, loading, and delivery only should be installed in an area in front of the residence located at 8731 Verbena Court, St. John, Indiana; and that Ordinance No. 511 should be amended consistent with the foregoing.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that Ordinance No. 511 shall be amended as follows, to-wit:

Sec. 13-91. Handicapped pick-up, loading, and delivery only.

"Handicapped pick-up, loading, and delivery only" posted signs shall be located at the intersections and upon the streets as provided in Schedule 20. Parking of vehicles for any purpose other than the foregoing is prohibited.

Sec. 13-1020. Schedule 20, Handicapped pick-up, loading, and delivery only.

- (a) This section may be cited as Schedule 20.
- (b) The following are zones in which the placement of Handicapped pick-up, loading, and delivery only signs shall be located:

In front of 8731 Verbena
Court, St. John, Indiana

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 511 when not in conflict herewith shall remain in full force and effect.

BE IT FURTHER ORDAINED that if any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this ordinance.

BE IT FURTHER ORDAINED that the Town Council declares that an emergency exists and that this ordinance shall take effect and be in full force and effect, from and after its passage by the Town Council of the Town of St. John, Lake County, Indiana.
