

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO. 1112

BEING AN ORDINANCE AMENDING ORDINANCE NO. 511, AND ALL AMENDMENTS THERETO, THE SAME BEING AN ORDINANCE REGULATING TRAFFIC, AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, on the 9th day of April, 1979, passed and adopted Ordinance No. 511, the same being an ordinance regulating traffic, and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the foregoing Ordinance has been amended on numerous occasions in order to protect the health, safety, and welfare of the citizens of the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from the St. John Public Works Department for the installation of eleven (11) stop signs and two (2) 20-mile per hour speed limit signs at various locations throughout the Town; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has come to the conclusion that Ordinance No. 511 should be amended and eleven (11) stop signs should be added as set forth and at the locations below and two (2) 20-mile per hour speed limit signs should be installed at the locations set forth below.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that Ordinance No. 511 shall be amended as follows, to-wit:

Sec. 13-1014. Schedule 14, three-way stops.

ADD TO (b) Manor Drive at West 108th Place

Sec. 13-1007. Schedule 7, stop streets.

ADD TO (b) Millard Drive at West 107th Avenue
Manor Drive at West 107th Avenue
Maloian Drive at West 107th Avenue
Manor Drive at West 109th Avenue
Monfort Drive at West 87th Avenue
Stark Court at Monfort Drive
Hoffman Place at Monfort Drive
Northeast corner of Patterson Street and West
83rd Place
Osage Road at West 83rd Place
Heron Lake Road at West 83rd Place

Sec. 13-1009. Schedule 9, 20-mile per hour speed zones.

ADD TO (b) West 83rd Place
Manor Drive

BE IT FURTHER ORDAINED that the Police Department is authorized to place a yellow flasher on the stop signs for no less than thirty (30) days to alert motorists of the new stop signs.

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 511 when not in conflict herewith shall remain in full force and effect.

BE IT FURTHER ORDAINED that if any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this ordinance.


BE IT FURTHER ORDAINED that this ordinance shall take effect and be in full force and effect, from and after its passage by the Town Council of the Town of St. John.
