

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO. 1149

BEING AN ORDINANCE AMENDING ORDINANCE NO. 511, AND ALL AMENDMENTS THERETO, THE SAME BEING AN ORDINANCE REGULATING TRAFFIC, AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, on the 9th day of April, 1979, passed and adopted Ordinance No. 511, the same being an ordinance regulating traffic, and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the foregoing Ordinance has been amended on numerous occasions in order to protect the health, safety, and welfare of the citizens of the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from the St. John Public Works Department to approve eight (8) new stop signs and one (1) 20-mph speed limit sign in Clarmonite Ridge, Unit 2, as set forth below; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from the St. John Public Works Department to approve one (1) new stop sign, one (1) 4-way stop sign, and one (1) 20-mph speed limit sign in Meyers Development, a PUD, as set forth below; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, now finds that Ordinance No. 511 should be amended and the additional stop signs and speed limit signs should be added as set forth and at the locations below.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that Ordinance No. 511 shall be amended as follows, to-wit:

Sec. 13-1007. Schedule 7, stop streets.

ADD TO (b) Berkley Lane at West 95th Place
Clarmonite Lane at West 95th Place
Clarmonite Lane at West 94th Place
Dover Lane at Clarmonite Drive
West 95th Place at Clarmonite Drive
Clarmonite Drive at West 95th Place
West 94th Place at Clarmonite Drive
Clarmonite Drive at West 93rd Avenue
Meadow Lane at U.S. Highway 41

Sec. 13-1008. Schedule 8, 4-way stops.

ADD TO (b) Meadow Lane and West 82nd Lane

Sec. 13-1009. Schedule 9, 20 mile per hour speed zones.

ADD TO (b) Clarmonite Drive (entrance off of
West 93rd Avenue)
Meadow Lane (entrance off of
U.S. Highway 41)

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 511 when not in conflict herewith shall remain in full force and effect.

BE IT FURTHER ORDAINED that if any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this Ordinance.


BE IT FURTHER ORDAINED that this Ordinance shall take effect and be in full force and effect, from and after its passage by the Town Council of the Town of St. John.
