

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO. 1194

BEING AN ORDINANCE AMENDING ORDINANCE NO. 511, AND ALL AMENDMENTS THERETO, THE SAME BEING AN ORDINANCE REGULATING TRAFFIC, AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, on the 9th day of April, 1979, passed and adopted Ordinance No. 511, the same being an ordinance regulating traffic, and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the foregoing Ordinance has been amended on numerous occasions in order to protect the health, safety, and welfare of the citizens of the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from the St. John Public Works Department at the request of the St. John Police Department for the installation of seven (7) additional stop signs, two (2) 20-mile per hour speed limit signs, and a no through street sign within the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has come to the conclusion that Ordinance No. 511 should be amended and seven (7) additional stop signs should be added, two (2) 20-mile per hour speed limit signs should be added, and a no through street sign should be added at the locations set forth below.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that Ordinance No. 511 shall be amended as follows, to-wit:

Sec. 13-1007. Schedule 7, stop streets.

ADD TO (b) West 90th Avenue at Schillton Drive (southwest corner)
Waverly Avenue at Randal Drive (southeast corner)
West 92nd Avenue at Randal Drive (southwest corner)
West 101st Place at Wicker Avenue/U.S. 41 (northeast corner)
West 101st Avenue at Wicker Avenue/U.S. 41 (northeast corner)
Earl Drive at West 101st Avenue (southeast corner)
Earl Drive at West 101st Place (northwest corner)

Sec. 13-1009. Schedule 9, 20-mile per hour speed zones.

ADD TO (b) West 101st Place (entrance to Ravenwood Business Center)
West 101st Avenue (entrance to Ravenwood Business Center)

Sec. 13-1015. Schedule 15, no through street signs.

ADD TO (b) Southbound on Hedwig Drive at Valley Court

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 511, as amended, when not in conflict herewith shall remain in full force and effect.

BE IT FURTHER ORDAINED that if any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this ordinance.

BE IT FURTHER ORDAINED that this ordinance shall take effect and be in full force and effect, from and after its passage by the Town Council of the Town of St. John.
