

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO. 1210

BEING AN ORDINANCE AMENDING ORDINANCE NO. 511, AND ALL AMENDMENTS THERETO, THE SAME BEING AN ORDINANCE REGULATING TRAFFIC, AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, on the 9th day of April, 1979, passed and adopted Ordinance No. 511, the same being an ordinance regulating traffic, and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the foregoing Ordinance has been amended on numerous occasions in order to protect the health, safety, and welfare of the citizens of the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from the St. John Police Department and the St. John Public Works Department to approve one (1) new 4-way stop sign at West 90th Avenue at Columbia Court; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, now finds that Ordinance No. 511 should be amended and the additional 4-way stop sign should be added as set forth and at the location below.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that Ordinance No. 511 shall be amended as follows, to-wit:

Sec. 13-1008. Schedule 8, 4-way stop streets.

ADD TO (b) West 90th Avenue at Columbia Court

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 511 when not in conflict herewith shall remain in full force and effect.

BE IT FURTHER ORDAINED that if any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this Ordinance.

BE IT FURTHER ORDAINED that the Town Council declares an emergency and that this ordinance shall take effect and be in full force and effect, from and after its passage by the Town Council of

the Town of St. John, Lake County, Indiana, pursuant to law.
