

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO: 1270

BEING AN ORDINANCE AMENDING ORDINANCE NO. 511, AND ALL AMENDMENTS THERETO, THE SAME BEING AN ORDINANCE REGULATING TRAFFIC, AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, on the 9<sup>th</sup> day of April, 1979, passed and adopted Ordinance No. 511, the same being an ordinance regulating traffic, and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the foregoing Ordinance has been amended on numerous occasions in order to protect the health, safety, and welfare of the citizens of the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from the St. John Public Works Department and the Chief of the Police Department to approve addition of two (2) new stop signs in Schillton Hills – Unit VII, and deletion of four (4) previously approved stop signs in Schillton Hills – Unit XII and Ray's Villa, as set forth below; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has come to the conclusion that Ordinance No. 511 should be amended and that two (2) new stop signs should be added, and four (4) new stop signs previously approved be deleted, as set forth and at the location below.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that Ordinance No. 511 shall be amended as follows, to-wit:

BE IT FURTHER ORDAINED that if any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this Ordinance.

BE IT FURTHER ORAINED that this Ordinance shall take effect and be in full force and effect, from and after its passage by the Town Council of the Town of St. John.
