

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO. 1281

BEING AN ORDINANCE AMENDING ORDINANCE NO. 511, AND ALL AMENDMENTS THERETO, THE SAME BEING AN ORDINANCE REGULATING TRAFFIC, AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, on the 9th day of April, 1979, passed and adopted Ordinance No. 511, the same being an ordinance regulating traffic, and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the foregoing Ordinance has been amended on numerous occasions in order to protect the health, safety, and welfare of the citizens of the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from the St. John Public Works Department and the Chief of the Police Department to approve eleven (11) new stop signs and five (5) 20 mph speed signs, as set forth below; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has come to the conclusion that Ordinance No. 511 should be amended and that eleven (11) new stop signs and five (5) 20-mph speed signs should be added as set forth and at the location below.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that Ordinance No. 511 shall be amended as follows, to-wit:

Schedule 7, Stop Streets

Ivy Avenue at Joliet Street - southbound
West 97th Court at Ivy Avenue - eastbound
West 95th Place at Ivy Avenue - eastbound
West 95th Place at Ivy Avenue - westbound
Ivy Avenue at West 95th Place - northbound

(Bramblewood – Unit I)

Bramblewood Drive at West 93rd Avenue - northbound
West 94th Avenue at Julia Drive - eastbound
West 94th Court at Julia Drive - westbound

West 96th Avenue at Julia Drive - eastbound
Julia Drive at West 96th Avenue - southbound
Julia Drive at West 96th Avenue - northbound

Schedule 9, 20 Mile Per Hour Speed Zones

Ivy Avenue - northbound from Joliet Street

Schedule 14, Three-Way Stop Streets

(Maginot Meadows – Unit I)

West 95th Place at Ivy Avenue - eastbound
West 95th Place at Ivy Avenue - westbound
Ivy Avenue at West 95th Place - northbound

(Bramblewood – Unit I)

West 96th Avenue at Julia Drive - eastbound
Julia Drive at West 96th Avenue - southbound
Julia Drive at West 96th Avenue - northbound

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 511 when not in conflict herewith shall remain in full force and effect.

BE IT FURTHER ORDAINED that if any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this Ordinance.

BE IT FURTHER ORAINED that this Ordinance shall take effect and be in full force and effect, from and after its passage by the Town Council of the Town of St. John.
