

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO: 1314

BEING AN ORDINANCE AMENDING ORDINANCE NO. 511, AND ALL AMENDMENTS THERETO, THE SAME BEING AN ORDINANCE REGULATING TRAFFIC, AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, on the 9th day of April, 1979, passed and adopted Ordinance No. 511, the same being an ordinance regulating traffic, and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the foregoing Ordinance has been amended on numerous occasions in order to protect the health, safety, and welfare of the citizens of the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from the St. John Public Works Department and the Chief of the Police Department to approve addition of thirty-two (32) new stop signs in Heron Lake – Unit 4A, Bramblewood – Unit 2, Heron Park – Unit 2, Weston Ridge – Unit 1, as set forth below; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has also received a request from the St. John Public Works Department and the Chief of the Police Department to approve addition of twelve (12) 20 – Mile Per Hour Speed Zone signs, as set forth below; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has come to the conclusion that Ordinance No. 511 should be amended and that thirty-two (32) new stop signs should be added, as set forth and at the location below.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that Ordinance No. 511 shall be amended as follows, to-wit:

BE IT FURTHER ORAINED that this Ordinance shall take effect and be in full force and effect, from and after its passage by the Town Council of the Town of St. John.


