

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO. 1333

BEING AN ORDINANCE AMENDING ORDINANCE NO. 511, AND ALL AMENDMENTS THERETO, THE SAME BEING AN ORDINANCE REGULATING TRAFFIC, AND ESTABLISHING FINES AND PENALTIES FOR VIOLATIONS OF TRAFFIC REGULATIONS IN THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, on the 9th day of April, 1979, passed and adopted Ordinance No. 511, the same being an ordinance regulating traffic, and establishing fines and penalties for violations of traffic regulations in the Town of St. John, Lake County, Indiana; and

WHEREAS, the foregoing Ordinance has been amended on numerous occasions in order to protect the health, safety, and welfare of the citizens of the Town of St. John; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has received a request from the St. John Public Works Department and the Chief of the Police Department to approve traffic signal additions, as set forth below; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has come to the conclusion that Ordinance No. 511 should be amended and that certain traffic signal additions, should be added as set forth and at the location below.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that Ordinance No. 511, Section 13-64 and the following traffic schedules shall be amended as indicated herein as follows, to-wit:

"SECTION 13-64 One-Way Streets and Alleys.

Upon those streets and alleys hereafter designated by the Town Council, vehicles shall move only in the indicated direction of travel."

(a) This section may be cited as Schedule 24.

(b) The following are one-way streets in which the placement of One-Way, Keep Right and Do Not Enter directional signs shall be located:

Weston Ridge – Unit 3

Olcott Avenue – northbound traffic entering Roundabout

West 107th Avenue – eastbound traffic entering Roundabout


BE IT FURTHER ORDAINED that this Ordinance shall take effect and be in full force and effect, from and after its passage by the Town Council of the Town of St. John.
