ORDINANCE # 1367

AN ORDINANCE AMENDING ORDINANCE #1349 OF THE TOWN OF ST. JOHN REGARDING WATERWORKS SYSTEM DEVELOPMENT CHARGE

WHEREAS, Ordinance #1349 of the Town of St. John did, among other things, establish a System Development Charge for the Waterworks System of the Town of St. John, and specifically, sets forth in Section One a chart outlining a schedule of charges; and

WHEREAS, said Section One Schedule of Charges incorrectly described the basis for the Waterworks System Development Charge as Meter Size rather than Service Line Size at Point of Connection; and

WHEREAS, it is the intent of the Town Council of the Town of St. John to base the Waterworks System Development Charge upon the service line size at the point of connection with the Town's distribution system; and

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana as follows:

Ordinance #1349- Section One should read as follows:


"SECTION ONE: Effective ~~July 1, 2004~~ <sup>February 1, 2004</sup>, a one time charge known as a System Development Charge will be collected from new customers of the Waterworks System in accordance with the following schedule:

5/8", 3/4", 1"	1.00	\$ 1,000.00	\$ 1,000.00
1 1/2"	5.00	\$ 1,000.00	\$ 5,000.00
2"	8.00	\$ 1,000.00	\$ 8,000.00
3"	15.00	\$ 1,000.00	\$15,000.00
4"	25.00	\$ 1,000.00	\$25,000.00
6"	50.00	\$ 1,000.00	\$50,000.00




