

TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

ORDINANCE NO. 1465

BEING AN ORDINANCE AMENDING ORDINANCE NO. 1456, THE SAME BEING AN ORDINANCE ESTABLISHING A SCHEDULE OF WAGES AND SALARIES FOR EMPLOYEES, FIRE AND POLICE PERSONNEL, AND TOWN OFFICIALS FOR THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA.

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, did, on the 27th day of December, 2007, adopt Ordinance No. 1456, the same being an ordinance establishing a schedule of wages and salaries for employees, fire and police personnel, and town officials for the Town of St. John, Lake County, Indiana; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, now finds it in the best interests of the town, to amend said Ordinance No. 1456, creating a schedule of wages and salaries and dates of payment for employees of various departments.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of St. John, Lake County, Indiana that the following schedule of wages and salaries and dates of payment therefore, for Department Personnel listed below, be and are hereby established, be and is hereby amended, and shall commence with pay period beginning February 2, 2008, and continue through pay period ending December 19, 2008, to wit:

(ADD – beneath position of Town Manager)

A. TOWN COUNCIL EMPLOYEES

Director of Operations

Not to exceed \$3,241.95 paid bi-weekly from the General Fund.

(ADD – beneath position of Assistant Chief)

C. POLICE DEPARTMENT EMPLOYEES

Captain

Not to exceed \$2,769.64 paid bi-weekly from the General Fund.

(ADD – beneath position of Public Works Director)

G. PUBLIC WORKS EMPLOYEES

General Foreman

Not to exceed \$31.77 per hour, paid bi-weekly from MVH, Water Utility, Wastewater Utility, Waterworks District or Sanitary District, in whole or in part.

Customer Service Representative

Not to exceed \$22.49 per hour, paid bi-weekly from MVH, Water Utility, Wastewater Utility, Waterworks District or Sanitary District, in whole or in part.

(AMEND - in place of position of Utility Foreman)

**Water / Wastewater
Operator**

Not to exceed \$30.77 per hour, paid bi-weekly from MVH, Water Utility, Wastewater Utility, Waterworks District or Sanitary District, in whole or in part.

(DELETE)

Utility Crew Leader

Not to exceed \$28.39 per hour, paid bi-weekly from MVH, Water Utility, Wastewater Utility, Waterworks District or Sanitary District, in whole or in part.

BE IT FURTHER ORDAINED that all ordinances, or parts of ordinances, policies, or parts of policies, in conflict with the provisions of this ordinance, are hereby repealed and declared to be null, void, and of no legal affect.

BE IT FURTHER ORDAINED that if any section, clause, provision, or portion of this ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision, or portion of this ordinance.

BE IT FURTHER ORAINED that an emergency exists for the immediate taking effect of this ordinance therefore, this ordinance is hereby passed and adopted by the Town Council of the Town of St. John, Lake County, Indiana, and shall become effective this 28th day of February, 2008.
