

**TOWN OF ST. JOHN, LAKE COUNTY, INDIANA
ORDINANCE NO. 1802**

**AN ORDINANCE AMENDING SALARY ORDINANCE NO. 1787 AND 1796, BEING AN
ORDINANCE ESTABLISHING THE 2023 COMPENSATION PLAN FOR THE TOWN OF ST.
JOHN, INDIANA, BUILDING AND PLANNING PERSONNEL**

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, (hereinafter "Town Council") on December 14, 2023, did adopt Town Ordinance No. 1787, which established wages and salaries for the Town of St. John, Lake County, Indiana, (hereinafter "Town") for Town Employees, Town Officials, Police Personnel, Fire Personnel, Building and Planning Department Employees, Park Department Employees, and Public Works Department Employees, which include Water Utility Employees, Wastewater Utility Employees, Street Department Employees, Sanitary District Employees, and Waterworks District Employees; and

WHEREAS, the Town Council finds that Ordinance No. 1787 and Ordinance 1796 should be amended to include a Building and Planning Department Executive Assistant and Building and Planning Department Intern Part-Time position respectively, to provide services to the Town of St. John; and

WHEREAS, the Town Council finds it advisable to amend EXHIBIT B of Ordinance No. 1787 and EXHIBIT C of Ordinance No. 1796; and

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF
ST. JOHN, LAKE COUNTY, INDIANA AS FOLLOWS:**

SECTION ONE. That EXHIBIT B of ORDINANCE 1787 more specifically "Executive Assistant", more specifically "Building and Planning is hereby amended as follows:

SECTION TWO. That EXHIBIT C of ORDINANCE 1796 more specifically "Building and Planning Part-Time Intern", is hereby amended as follows:





SECTION FIVE. That this Ordinance shall take effect retroactive to June 5, 2023, and be in full force and effect as approved by the Town Council of the Town of St. John, Lake County, Indiana.
