RESOLUTION NO. 02-09-26B

BEING A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, AUTHORIZING THE SALE OF CERTAIN HEALTH AND FITNESS CENTER EQUIPMENT TO THE TOWN OF DYER, LAKE COUNTY, INDIANA.

WHEREAS, the Town of St. John, Lake County, Indiana owns certain health and fitness center equipment which was originally purchased for the Health and Fitness Center at the St. John Ice Arena; and

WHEREAS, inasmuch as the Ice Arena building has been sold and/or transferred, the health and fitness center equipment is of no bona fide use to the Town of St. John and has become available for sale; and

WHEREAS, the Town Council has had said property duly appraised and is advised that I.C. 36-1-11-8 and I.C. 5-22-22-10 allow the sale of personal property by one governmental body to another governmental body upon terms and conditions agreed upon by the governmental bodies as evidenced by the adoption of a substantially identical resolution by each entity; and

WHEREAS, the Town Council of the Town of St. John is advised that the Police Department of the Town of Dyer ("Town of Dyer") is desirous of purchasing the aforesaid health and fitness center equipment and has made an offer to purchase the same.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, AS FOLLOWS:

1. That the sale of the health and fitness center equipment located at the St. John Ice Arena, a list of which is attached hereto and made a part hereof as Exhibit "A", to the Town of Dyer for the sum of \$ 5,325.00 is hereby approved.
2. That the Town Manager of the Town of St. John is hereby authorized to transfer said health and fitness center equipment to the Town of Dyer and in exchange for a one-time payment in the sum of \$ 5,325.00, which payment shall be made within ten (10) days from the date of transfer of the equipment.
3. That this transaction between the Town of St. John and the Town of Dyer shall be evidenced by the passage by both entities of a substantially identical resolution or the same shall be deemed null and void.
4. That the aforesaid equipment is sold "as is" in its current condition and by accepting such, the Town of Dyer acknowledges same; and that said equipment is being transferred by the Town of St. John without any warranties of any kind, express or implied, including but not limited to any warranty of merchantability or fitness for particular purpose.
