RESOLUTION NO. 08-02-28

A RESOLUTION TO WITHDRAW AND RESCIND TOWN RESOLUTION NO. 05-01-20, BEING: "A RESOLUTION ELECTING THE TOWN'S FULL-TIME FIREFIGHTERS AND EMERGENCY MEDICAL TECHNICIANS TO JOIN THE 1977 POLICE AND FIREFIGHTERS' PENSION AND DISABILITY FUND AS ADMINISTERED BY THE PUBLIC EMPLOYEE'S RETIREMENT FUND", AND ALL MATTERS RELATED HERETO.

WHEREAS, the St. John Town Council is the governing body of the Town of St. John, Lake County, in the State of Indiana; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, has been advised regarding the necessary requirements and obligations associated with the Town's full-time firefighters and emergency medical technicians joining the 1977 Police and Firefighter's Pension and Disability Fund, as administered by the Public Employee's Retirement Fund (PERF); and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, was further advised that it was in the best interest of the Town for the Full-Time Firefighters and Emergency Medical Technicians to join the 1977 Police and Firefighter's Pension and Disability Fund only upon obtaining the Social Security Administration's approval to exempt the Town from withholding social security taxes from the certified salary paid to the participating employees; and

WHEREAS, the Town Council of the Town of St. John, Lake County, Indiana, after extensive research, is now advised that the establishment of the St. John's Firefighter's Pension Fund and participation in the 1977 Police and Firefighter's Pension and Disability Fund may result in serious unanticipated financial hardship to the Town.


NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, AS FOLLOWS:

SECTION ONE: The Town Council of the Town of St. John, Lake County, Indiana, hereby withdraws and rescinds its election under Resolution No. 05-10-20 to become a participating unit in the 1977 Police and Firefighter's Pension and Disability Fund, as established by Public Law No. 9 (Special Session 1977), and all Acts amendatory thereof and supplemental thereto.




