RESOLUTION NO. 2018-18-18

A RESOLUTION APPROVING AND ADOPTING A 2019-2024 ST. JOHN PARKS AND RECREATION PLAN FOR THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, AND ALL MATTERS RELATED THERETO.

WHEREAS, the Town of St. John, Lake County, Indiana, has established, by appropriate enabling Ordinance, under applicable Indiana Law as amended from time to time, a Department of Parks and Recreation in the Town, which Department is governed by its duly appointed Board of Parks and Recreation (hereinafter "Park Board"); and

WHEREAS, the Park Board is aware and has been advised of the provisions of the Indiana Code relating to Parks and Recreation that adoption of a 2019-2024 St. John Parks and Recreation Plan is required and appropriate to address, identify, and plan the Park and Recreation needs of the residents of the Town of St. John; and

WHEREAS, the Park Board oversees and establishes the rules, responsibilities and plans for the provision of park and recreation needs for the residents of the Town of St. John by and through, in part, its adopted 2019-2024 St. John Parks and Recreation Plan; and

WHEREAS, the Park Board seeks to continue to provide aesthetic and functional park and recreation facilities and programs to the residents of the Town of St. John to meet the physical, social, psychological and communal recreational needs of the residents of the Town; and

WHEREAS, the Park Board recognizes and acknowledges the importance of planning and preparation in order to meet the physical, social, psychological and communal recreation needs of the residents of the Town in the provision of aesthetic and functional park and recreation facilities and programs to said residents while remaining continuously aware of the value and importance of leisure opportunities, recreational programs and functional facilities operated and conducted by the Town of St. John Department of Parks and Recreation in its programs for the benefit of the residents of the Town; and

WHEREAS, the Park Board acknowledges the requirements of applicable law to adopt a 2019-2024 St. John Parks and Recreation Plan, and in such recognition, has updated and prepared a current 2019-2024 St. John Parks and Recreation Plan for the Department of Parks and Recreation of the Town in conformance with applicable law, as well as to meet the objectives of the Town Park Board set forth hereinabove; that a copy of the current proposed 2019-2024 St. John Parks and Recreation Plan presented to the Town Park Board for the Town Department of Parks and Recreation for the time period of 2019 to 2024 is attached hereto and incorporated herein.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA, BOARD OF PARKS AND RECREATION, AS FOLLOWS:

SECTION ONE: That the Town of St. John Board of Parks and Recreation hereby approves and adopts the 2019-2024 St. John Parks and Recreation Plan, which is attached hereto, presented to it for such approval consideration for the time period of 2019 to 2024 as its official plan for the growth and development of parks and recreation opportunities in the Town of St. John, Indiana, for the time period stated. Further, the Town of St. John Park Board hereby directs the annual review of the adopted 2019-2024 St. John Parks and Recreation Plan by the Town Department of Parks and Recreation, and its

Administrative Staff, for report recommendation to the Town Park Board, with an update of the goals and objectives to be presented annually to the Town Park Board by Park Department personnel on the status of meeting the goals and objectives of the adopted Master Plan.

SECTION TWO: That the duly adopted 2019-2024 St. John Parks and Recreation Plan is hereby directed to be published, and copies of same are directed to be distributed to the Members of the St. John Town Council, Town Clerk-Treasurer, Town Manager, and Park Department Administrative Staff, with copies available for the public, if requested. The Parks Superintendent is directed to undertake such distribution, and report compliance with such distribution to the Town Park Board thereafter.

SECTION THREE: That this Resolution shall take effect, and be in full force and effect, from and after its passage and approval, in conformance with applicable law.

The Applicant-Recipient recognizes and agrees that such Federal financial assistance will be extended in reliance on the representations and agreements made in this assurance, and that the United States shall reserve the right to seek judicial enforcement of this assurance. This assurance is binding on the Applicant-Recipient, its successor, transferees, and assignees, and the person or persons whose signatures appear below are authorized to sign this assurance on behalf on the Applicant-Recipient.
