

RESOLUTION NO. 2022-10-26

A RESOLUTION OF THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA,
 AUTHORIZING ADDITIONAL APPROPRIATIONS
 FOR THE ST. JOHN FISCAL RECOVERY PLAN
 IN THE ARP CORONAVIRUS LOCAL FISCAL RECOVERY FUND, FUND 2402

WHEREAS, the Council has previously approved Resolution No. 1775, which approved the St. John Fiscal Recovery Plan; and

WHEREAS, the Council previously included in the 2022 budget for the spending of the first tranche of ARP monies that the Town received during 2021 in the amount of \$2,121,811; and

WHEREAS, the Town has now received the second tranche of ARP monies, as well as a small supplement receipt; and

WHEREAS, the Council is aware an additional appropriation process is needed to approve the spending of the additional receipts to be used to carry out the St. John Fiscal Recovery Plan; and

WHEREAS, the Council is aware that the Fund currently holds a sufficient cash balance to support the requested additional appropriations of; and

WHEREAS, the American Rescue Plan allows for the eligible costs to have been incurred from March 3, 2021, through December 31, 2024; and






