RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA CLARIFYING AN ASSESSMENT ROLL RELATED TO THE ST. JOHN INDUSTRIAL CENTER SEWERS BARRETT LAW PROJECT

WHEREAS, IC 36-9-39 (the "Act") permits the Town Council of the Town of St. John, Indiana (the "Town"), to construct sewage works and fund the construction of such improvements through the issuance of bonds payable from barrett law assessments received from property owners which benefit from the constructed improvements; and

WHEREAS, the Town has been requested by property owners to construct storm sewers that will provide drainage to the St. John Industrial Center (the "Project"); and

WHEREAS, the Project has been completed for a total cost of \$55,800, which includes all incidental, legal, inspection and engineering costs, and costs of maintenance of the Project for three years; and

WHEREAS, the Town Council has finally approved an assessment roll for the property abutting on and adjacent to the Project that is to be assessed for the cost of the Project and the property owners have been notified of the amount of such assessments; and

WHEREAS, such assessments are based on the square footage of each property owner's property; and

WHEREAS, the Town Council desires to clarify the assessment roll by stating the amount of the assessment applicable to each lot owned by the property owners based on the square footage of such lot, as set forth on Exhibit A hereto (the "Clarified Assessment Roll").

NOW, THEREFORE, BE IT RESOLVED BY TOWN COUNCIL OF THE TOWN OF ST. JOHN, INDIANA, AS FOLLOWS:

- 1. The Town Council hereby adopts and approves the Clarified Assessment Roll. The Clarified Assessment Roll shall be final and conclusive on all parties.
- 2. The Clarified Assessment Roll shall be delivered to the Clerk-Treasurer who shall notify the Property Owners of such clarification of their respective assessments.
 - 3. This Resolution shall be in full force and effect upon its adoption.
