A RESOLUTION OF THE TOWN OF ST. JOHN PLAN COMMISSION
RECOMMENDING TO THE TOWN COUNCIL PRESIDENT THE
RENAMING OF CERTAIN STREETS WITHIN THE TOWN
LIMITS OF THE TOWN OF ST. JOHN, LAKE COUNTY, INDIANA

WHEREAS, the Plan Commission of the Town of St. John, Lake
County, Indiana, pursuant to I.C. 36-7-4-405, may recommend to
the Town Council president the naming and renaming of streets
within the Town limits of the Town of St. John, Lake County,
Indiana; and

WHEREAS, the Plan Commission has determined that certain
streets within the Town limits of the Town of St. John, Lake
County, Indiana, be renamed to avoid duplication and to simplify
the same for all concerned; and

WHEREAS, it recommended by the Plan Commission that the
following streets be renamed as follows:

- A. 123rd to West Oakwood
- B. West 120th North of Oakwood to North Oakwood
- C. West 120th South of Oakwood to South Oakwood

NOW, THEREFORE, BE IT RESOLVED by the Plan Commission of the
Town of St. John, Lake County, Indiana, that the following
streets be renamed and the same are hereby recommended to the
Town Council president as follows:

- A. 123rd to West Oakwood
- B. West 120th North of Oakwood to North Oakwood
- C. West 120th South of Oakwood to South Oakwood

pursuant to I.C. 36-7-4-405.
